**AGREEMENT For participation in the National Pro-Life Youth Conference**  
**READ THIS CAREFULLY**

In consideration of being permitted to participate in the activity or excursion, and for other good and valuable consideration, the receipt and sufficiency of which is acknowledged, I hereby agree as follows:

**TO WAIVE ANY AND ALL CLAIMS** that I have or may in the future have against the Saskatchewan Pro Life Association Inc. arising out of any aspect of my participation in the National Pro-Life Youth Conference.

**TO RELEASE** the Saskatchewan Pro Life Association Inc. from any loss, damage, expenses or injury, including death, that I may suffer or that my next of kin may suffer during my participation in the National Pro-Life Youth Conference, due to any cause whatsoever, including negligence, breach of contract, or breach of any statutory or other duty of care on the part of the Saskatchewan Pro Life Association Inc. and also including failure on the part of the Saskatchewan Pro Life Association Inc. to safeguard or protect me from the risks, dangers, and hazards referred to above: and

**TO HOLD HARMLESS AND INDEMNIFY** the Saskatchewan Pro Life Association Inc. from any and all liability for any property damage, personal injury, health risks to me or any third party resulting from my participation in the National Pro-Life Youth Conference.

This Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns, and representatives, in the event of my death or incapacity: this Agreement and any litigation involving the parties to this Agreement shall be governed by and interpreted in accordance with the laws of the Province of residence of the participant and the Province of which the activity or excursion is held.

In entering into this Agreement, I am not relying upon any oral or written representation or statements made by the Saskatchewan Pro-Life Association Inc. with respect to the safety of the trip or excursion, other than what is set forth in this Agreement.

I agree to allow my registration form to be released to the Saskatchewan Pro Life Association Inc. knowing that the Saskatchewan Pro Life Association Inc. will not sell or distribute my information to third parties without my permission.

I hereby consent to the collection and use of photographs, video footage at the National Pro-Life Youth Conference of my child (or self) for the purpose of promoting the Saskatchewan Pro Life Association Inc.
