# **EDITORIAL** Faith, Fear, and Freedom



I'd begun writing numerous 'political' editorials, but each one invariably led me down a long rabbit hole of

sarcasm or despair. Mercifully, space considerations, and God's grace, will rein me in this time around.

Regrettably, I must disclose that due to other considerations, there may not be a 'next time' -at least not in CLN's current incarnation. Lest I sound alarmist. I must forewarn that this could be our last printed issue. The reason can be summed up in two words: supply chain. It's not the first time you've seen that phrase, and it won't be the last.

In Canada's printing industry, 75 percent of all paper utilized comes from overseas. I am unsure whence CLN's paper supply originates (mea culpa), but it should surprise no one that the world's number one exporter of paper is China. Will our great-grandchildren curse us for outsourcing most of our manufacturing to a country that specializes in censorship, oppression, slave labour, and killing its own citizensor will our nation by then so resemble China that Canadians have only to admire our basic dictatorship?

Long story short: with the 'Covideconomy' and shipping industry in a state of flux, there is no guarantee that SPLA will be able to source the speciallysized press sheets upon which CLN is printed-or if we can, that we'll be able to afford them. We are planning (hoping, praying) to produce a Summer issue, but all bets are off.

Should we be forced to delay or cancel, I urge supporters to share their email addresses with the SPLA office. For now, we should still be able to manage letters, in order to stay in touch with those who rely solely on snail mail. In

the meantime, our board and Choose Life News committee are discussing feasible options for carrying on.

It can be frightening to ponder the future, and society's "leaders" (I use the term loosely) have taken full advantage of that, since-well, forever, but particularly in the last two-plus years. Despite their mawkish assurances that they want us to be "safe," they demonstrate by their words and actions that they want us to live in fear.

There's always a monster around the corner, be it a virus, a doomsday climate scenario, or the notion that Canada will be overtaken by shadowy "fringe" elements who have "unacceptable views" (ie. social conservatives, Christians, and now, apparently, truckers-even the vaccinated ones).

I freely admit that both sides in any debate tend to engage in fear-peddling: it does generate more clicks than sweetness and light. Any student of history (and totalitarian dictatorships) must be feeling nervous after seeing what our western governments have pulled off over the last two years. How many more God-given rights and freedoms will they take away? How many more lockdowns? How much further will censorship go? Will the prolife movement survive? What kind of world will our grandchildren inherit?

The only way to live in peace is to have faith and let go of fear. God does not promise to keep us safe, but he does promise us love, wisdom, courage, and every other virtue we require to do his work. Many generations of humans have survived plague, famine, war, financial collapse, deceitful media, corrupt bureaucracies, and ruthless dictators-what makes us think we would be spared any of that? And what makes us think we cannot conquer it?

No one can defeat us-or steal our joy-if we are not afraid. Trust in God. Build his kingdom. Let us pray for Canada, the pro-life movement, and one another.

# **PRESS RELEASE:** WE NEED A LAW **Free Speech Court Victory**

The Ontario Divisional Court ruled [Jan.26] that the city of Guelph's decision to remove pro-life bus ads was unreasonable in light of the Charter. "We're happy to see the Court confirm that we have the freedom to express the pro-life viewpoint," said Tabitha Ewert, the lawyer who represented the Association for Reformed Political Action (ARPA) Canada as an intervener in this case. "The city had failed to recognize the Charter guarantee of freedom to expression by exclusively relying on a private body's opinion on the ads. But the city can't opt out of their constitutional responsibilities and we're thankful the court affirmed that with their ruling."

The city of Guelph had relied on the advice of Advertising Standards Canada - a private, industry group that offers its opinions on the accuracy and appropriateness of ads. "We argued that a private organization like Ad Standards isn't in the position to consider the Charter rights at play. It's not their role, nor do they have the expertise necessary to do so," Ewert said.

"The Court affirmed the arguments of the pro-life group, Guelph and Area Right to Life: The City improperly relied on Ad Standards' rulings without giving any considerations to its right to freedom of expression." Ewert commented on the court's reasoning: "The Court strongly affirms that the responsibility of respecting freedom of expression falls squarely on the city. They have a responsibility to uphold the Charter, and they can't opt out of that duty by pointing to Ad Standards' opinions."

The Court ruled that the city of Guelph's decision was unreasonable and remitted it back to do a proper Charter balancing of the interests at stake. For further comment please contact Tabitha Ewert (EDT) at 1-866-410-9625 or email tabitha@weneedalaw.ca

# ASSISTED SUICIDE Death is Becoming an Industry

### Euthanasia Opponents Bemoan Rise in Medically Assisted Deaths in Canada

Recently released statistics and anecdotal accounts have caused antieuthanasia activists increased concern, as they believe medically assisted death is not only permitted, but encouraged. Medically assisted deaths in Quebec rose to 2,426 in the year ending March 31, 2021—an increase of 37 percent over the year before, and represented 3.3 percent of all deaths. The statistics were made public by the province's commission on end-of-life care, which submitted its report to the Quebec parliament on Oct. 20, 2021.

Alex Schadenberg, executive director of the Euthanasia Prevention Coalition, said the [Quebec] increase is only slightly higher than rates in the rest of Canada. Since medical assistance in dying (MAiD) became legal in 2016, the number of Canadians who opted for the procedure rose from just over 1,000 in 2016 to 7,595 in 2020, according to Health Canada.

Schadenberg said MAiD has gained momentum since the Liberal government introduced and passed legislation to expand the scope as to who can receive the procedure. "In the discussion leading up to Bill C-7, all of the cultural taboos about killing people with disabilities or extending this to people with mental health issues and things like that, it was breaking down the negativity or the concept of maybe it's not a good idea to do this to anyone for any reason," he told The Epoch Times.

"The more we talk about it, the more it will happen. The more people will promote it, the more people will think it's fine and the more people will die this way. ... In a sense, death is becoming an industry. The fact is that all these things have moved our social mores."

Schadenberg has been a vocal opponent of euthanasia since the initial bill for its legalization was debated in 2016. In recent months, he helped steer a former pro-life leader from following through with MAiD after he received a phone call from the man's wife.

"She's calling me up all upset, saying, 'My husband would have never supported this, never. What's happening?' And we had a long

discussion. She found out that the one nurse in palliative care had spoken to him for two hours in the middle of the night, convincing him that it was the right thing to do," he said.

"They say this is all about freedom and choice and autonomy, and yet you're getting calls like this."

Angelina Ireland, president of the Delta Hospice Society, is fundraising for a new private facility after the society's former facilities, Irene Thomas Hospice and the adjacent Harold and Veronica Savage Centre for Supportive Care, were seized by the B.C. government due to their refusal to offer MAiD on-site. The facilities it built were on land owned by the health authority.

"It's like one big killing free-for-all," Ireland said, regarding societal trends on assisted death. "They can kill you at your home, the hospital, long-term care facility, hospice, and now the funeral home. But if one actually wants to live that's a lot more difficult. With the firing of thousands of health-care workers across Canada, we cannot so easily access even routine surgeries and tests for our own well-being. Where are the priorities?"

Amy Hasbrouck, a Quebec resident and executive director of "Toujours Vivant -Not Dead Yet," a project of the Council of Canadians with Disabilities, said the disabled have actively opposed euthanasia for over 35 years. "Consciousness was made during the landmark case when Robert Latimer killed his 12-year-old daughter, [Tracy]. And while the court engaged appropriately by convicting and sentencing him to the usual sentence, the amount of public support he received for his desire to have a more lenient sentence was really shocking to those with disabilities," Hasbrouck said in an interview.

"We're accustomed to being considered more disposable and less valuable, but we were fairly surprised that people were so overt in their declarations that Tracy's life was not worth living." The Truchon decision in Quebec in September 2019 legalized euthanasia for the disabled across Canada, a


decision Hasbrouck believes did more to devalue people with disabling health conditions than to empower them.

"The judge, basically, instead of saying, 'You're right. That's the problem of our public policies and the way we treat disabled people. We need to do things differently,' she said, 'Oh, yes. You're right. You should have the right to be killed by the state because, of course, you wouldn't want to go into a nursing home," Hasbrouck said. "So the judge's solution was, they would be better off dead."

In 2020, Jonathan Marchand, a Quebec City man with muscular dystrophy, camped out in a makeshift cage in front of the Quebec National Assembly for five days to protest his confinement in a nursing home due to the lack of independent living options for people with disabilities. "Quebec resisted and dragged their feet. And ultimately, they allowed Jonathan to create a program for himself, but they refused to extend the pilot project to other people. ... [Yet] it costs less for somebody to live in the community than for the person that lives in an institution," Hasbrouck said.

"It became much more apparent during the COVID pandemic that society in general considered disabled people [and the elderly in nursing homes] as a disposable population. Those are trends that we have seen most recently that are very worrisome." **•**

# 2021 FEDERAL ELECTION UPDATE Results for Pro-life MPs

#### **More Pro-life MPs Elected**

Despite a difficult election with an unpopular Conservative leader who constantly held up his pro-abortion credentials and offered no policies on reducing the abortion rates, RightNow was able to work with local pro-life supporters across the country to increase the number of pro-lifers elected to the House of Commons. This marks the second consecutive federal election (and incidentally, the second federal election of RightNow's existence) where the number of prolifers elected has increased from 40 in 2015, to 68 in 2019, to 74 in 2021. Your investment in RightNow is already paying dividends!

#### **Pro-life Incumbents Were Saved**


Given that our organization has very limited resources, we focused the majority of our efforts on retaining the pro-life seats we already had in the House of Commons. We identified 16 pro-life MPs who were running for reelection but polling poorly. We named this plan Operation Rescue,

understanding the historical significance of the name. We were able to recruit and distribute over 250 volunteers across Canada, including over 1,000 weekly door-knocking hours into the 16 target ridings. The result? We were able to rescue 13 of the 16 pro-life MPs and help ensure their re-election to the House of Commons.



#### **Pro-abortion Candidates Lost**

Of the 242 Conservative Party of Canada candidates who were either proabortion or refused to interview with RightNow prior to election day (and thus did not receive assistance from the pro-life movement), 45 of them were elected (a success rate of less than 20%). Naturally, this pales in comparison to the 96 known pro-life Conservative Party of Canada candidates, of whom 74 were elected for a success rate of 77%!

# SMALL STEPS ON PARLIAMENT HILL Passage of Kmiec's Bereavement Bill is Positive News for Pro-lifers

If you weren't paying attention last December, you may have missed it–a small win for pro-lifers in a sea of antilife, anti-freedom federal legislation. In late December, *True North* journalist Cosmin Dzsurdzsa ran a story titled, "Conservatives and Liberals strike lastminute deal on leave for bereaved parents" **(tnc.news).** The effort was initiated by Conservative MP Tom Kmiec (Calgary–Shepard) who lost his daughter Lucy-Rose in 2018 when she was just 39 days old.

The law change will now allow grieving parents employed in the public sector or federally-regulated industries to take eight weeks of unpaid leave after the death of a child. Before that, bereaved parents could take a maximum of ten days of leave, five of which were unpaid. The extended leave is available to parents who lose a child under the age of 18, a disabled child in their care, **or parents who have a stillborn baby following 20 weeks' gestation.**  Kmiec had introduced a private member's bill (C-211) before the 2021 election, but the dropping of the writ halted that effort. However, in December the Conservative MP tried again, this time including his bill in the passage of Bill C-3 (An Act to amend the Criminal Code and the Canada Labour Code) which was passed before Christmas.

Granted, other aspects of Bill C-3 are far from benign: the bill contains wording and intent similar to Saskatchewan's recent bubble zone legislation. While ostensibly claiming to ensure the 'safety' of healthcare workers, it also has the potential to thwart citizens' rights to peaceful protest. Please become familiar with what is in this bill and contact your MP with your questions and concerns.

However, it is still incumbent upon prolifers to appreciate any gains in the direction of fostering a culture of life, and Tom Kmiec's bereavement portion of the bill certainly does this. To quote one SPLA board member: *This has*

opened the door for further political debate on when life begins... Why are parents being given extended leave from work to grieve? What/Whom are they grieving? Twenty weeks gestation seems to be a starting point that politicians on all sides of the House have acknowledged with the passing of this bill. We are thankful for any progress being made in the right direction to respect human life from conception. ♥

# **SK Bubble Zone Update**

In the name of "safety," and under the auspices of COVID restrictions, the Saskatchewan government has effectively banned prayer, witness, free speech, and freedom of assembly in certain areas.

November 24, 2021: Passage of Bill 48 (*The Public Health (Safe Access to Hospitals) Amendment Act, 2021)* creates a 50-metre "safe access zone" around provincial hospitals. Ostensibly aimed at keeping vaccine-mandate protests away from hospital property, the bill also bans any non-union protests, including those organized by pro-life advocates.

December 2, 2021: Passage of Bill 66 (*An Act to amend The Education Act*) creates 50-metre anti-free speech zones around every school in the province.

Josie Luetke, Campaign Life Coalition's Youth Coordinator, criticized the province's government for betraying preborn children along with pro-life advocates.

"Scott Moe's government was not only the first relatively 'pro-life' government to pass 'bubble zone' legislation, but also the first conservative government to do so. When so-called 'pro-life' conservatives are doing the work of social liberals and the censorious leftwing elite, we've lost any sense of meaningful ideological diversity," she said.



The Festival runs for three weeks, and the entire community parades through the park to view the light displays. We came up with a nightly one-liner for a radio station which will be played in the evening during inspirational broadcasting: it is a 10-second ad for pro-life that runs the entire year. We also placed two ads in the paper for December, one for the quilt raffle and one for a Christmas greeting. Our group also ordered three amazing pro-life movies that we will use for private showings: the theatres are too regulated so we're going to show them in a church. The films are *Gosnell*, the trial of America's biggest serial killer; *Roe versus Wade*, the real story you've never been told; and *Unplanned* – based on a true story. We had already brought *Unplanned* into Estevan when it was released and it sold out the first day, so they played it a second day—at the movie theatre!

In mid-December we were very upset to learn that our beautiful display at the Festival of Lights had been vandalized. The RCMP took pictures, and will examine footage from a trail-cam nearby the St Joseph's Hospital display, where the baby Jesus figurine was stolen. As far as we are aware, no other vandalism at the Festival of Lights took place. We know that haters are going to hate but it's no less crushing when something like this happens. ♥
















# SASKATOON Memorial Mass Held


relationships that will help them reach more people and create more pro-life opportunities for all ages. ♥




